4. If Any of the payments indicated above are not made in a timely fashion, then debtor agrees that the amount due and owing shall be the amount prayed for in the Complaint (OR \_\_\_\_\_) less any payments received.

If no Final Judgment has been entered herein, if no affidavit of nonpayment has been filed herein, if this case has not been dismissed sooner, and when 30 days have passed after the time for making the last payment provided for herein, this Stipulation shall constitute a voluntary dismissal of the claim or complaint, and of the counterclaim, if any, filed herein, and a consent to the release of any bond involved in the cause.
