# Gallatin County Road and Bridge Department Application for an Approach Encroachment Permit

Pursuant to Title 7, Chapter 14, MCA, inter alia, any person or agency performing any work in a County Road right of way must first obtain an encroachment permit from the Road and Bridge Department. Encroachment permits are issued for driveways, road approaches, underground and aerial utility work, and any other kind of work performed or structure placed within the road right of way.

The term "encroachment" includes but is not limited to any tower, pole, poleline, pipe, pipeline, driveway, private or public road, fence, walkway, path, trail, stand or building, or any structure or object of any kind or character not particularly mentioned in this section, which is placed in, under or over any portion of the County Road right of way.

A certificate of insurance, naming Gallatin County as additional insured in the amount specified by the County shall be received by the Road Office from the applicant's contractor prior to the permit being issued.

#### An application fee of \$125 is required.

Encroachment permits are issued for a ninety (90) day period. All construction work must be complete within the 90 day period unless otherwise stated on the Encroachment Permit. If a longer period of time is needed please indicate that on the installation schedule. Upon written request, an extension may be granted by the Gallatin County Road and Bridge Department for up to an additional 90 days.

This application is not a permit. No construction/work may start until an official Gallatin County Encroachment Permit has been issued and validated by this Department. If the application is approved, the applicant will be required to sign the permit acknowledging acceptance of all of the conditions. The Encroachment Permit is not valid until signed by a Gallatin County Road and Bridge Department Representative.
