## When you don't know what to do... Guidelines for Family Members and Persons Suffering From Mental Health Issues



### Emergency Help

If you or a relative are not currently under the care of a local mental health professional, but you are having a mental health crisis:

- ◆ Insist that a mental health professional, such as a mental health counselor, psychologist, psychiatrist or a psychiatric nurse practitioner, meet with you **NOW!**
- ◆ Call the Help Center's 24-hour crisis line at **586-3333**

If you or a relative is currently under professional care, but the treatment is not effective:

- ◆ Insist that your mental health professional meet with you and listen to you to reevaluate your treatment program.
