

Dog Ordinances

Dog At Large

Ordinance 2003-01-4

"At Large" Shall mean any dog off the premises of the owner or temporary owner and not under immediate control by a reasonable leash, tether, lead, or other physical control devices, hand control, voice control or signal control of a capable person

Vicious and Dangerous Dog

Ordinance 2003-01-5

"Vicious Dog" Shall mean any dog which bites or attempts to bite any human being without provocation. "Dangerous Dog" shall mean any dog which harasses, chases, bites or attempts to bite any animal.

Barking Dog

Ordinance 2003-01-06

A barking dog is a dog which unreasonably annoys or disturbs any person by continuously and habitual barking, howling, yelping, crying or whining.

Cruelty to Animals

MCA 45-8-211

It is illegal to mistreat or neglect an animal by beating, tormenting, injuring, killing, or carrying an animal in a cruel manner, or failing to provide such animal with proper drink, food, and shelter or abandoning an animal where it becomes a public charge.

Rabies Vaccination and Control

Ordinance 2003-01-8

It is unlawful to be an owner of a dog over the age of 6 months that is not currently vaccinated for rabies and is not wearing a collar with a tag showing proof thereof.
