WHEREAS, the Gallatin County Plan was adopted on June 1, 1993, by Resolution 1993-14 of the Gallatin County Commission; and

WHEREAS, the Gallatin County Plan was revised on October 20, 1998, by Resolution 1998-74 of the Gallatin County Commission; and

WHEREAS, the Gallatin County Plan was revised on July 13, 1999, by Resolution 1999-42 of the Gallatin County Commission to include the 1990 Bozeman Area Master Plan Update as a neighborhood area plan; and

WHEREAS, Section 76-1-601, et seq., MCA, establishes the requirements for revisions to the Gallatin County Plan; and

WHEREAS, adoption of the Gallatin County Trails Plan would establish an official public policy on trails planning to promote the orderly development of the jurisdiction of the Gallatin County Planning Board; and

WHEREAS, adoption of the Gallatin County Trails Plan would supercede public policy on trails planning in the 1990 Bozeman Area Master Plan Update neighborhood area plan portion of the Gallatin County Plan; and

WHEREAS, after legal notice, the Gallatin County Planning Board held a public hearing on October 23, 2001; and voted 7-0 (1 abstaining) to forward Resolution No. 2001-04 to recommend the adoption and implementation of the Gallatin County Trail Plan, dated March 2001, as a revision of the Gallatin County Plan; and

WHEREAS, notice of the Gallatin County Commission public hearing on the Gallatin County Trails Plan was published in the High Country Independent Press on November 22 and 29, 2001; and

WHEREAS, notice of the Gallatin County Commission public hearing on the Gallatin County Trails Plan was not posted on the site nor mailed to adjoining property owners since the document applies to the entire jurisdiction; and

WHEREAS, the Gallatin County Commission received comments, recommendations and suggestions from the public; and

WHEREAS, after the public hearing, and public testimony, the Gallatin County Commission considered the staff report, recommendations and suggestions; and

WHEREAS, the Gallatin County Commission deem the adoption of the Gallatin County Trails Plan to be in the public interest; and

WHEREAS, on December 18, 2001, Gallatin County Commission passed a resolution of intention to adopt the Gallatin County Trails Plan; and

WHEREAS, notice of passage of the resolution of intention to adopt the Gallatin County Trails Plan was published in the High Country Independent Press on December 20 and 27, 2001.

NOW, THEREFORE, BE IT RESOLVED:

The Gallatin County Commission adopt "Connecting Communities: Gallatin County Trails Report and Plan" (Gallatin County Trails Plan) as a revision to the Gallatin County Plan.
