

# Section 6 A-S Motocross Snowmobile Interpretation of Use Classification

THEREFORE IT IS NOW HEREBY ORDERED by the Gallatin County Commission that "Motorcycle Track and Jumps" shall be interpreted to be a prohibited use in the AS Sub-District of the Gallatin County/Bozeman Area Zoning District.

### Section 10 RMH 2008, May Silva Admin Determination

Stick-built single-family homes are permitted in the R-MH subdistrict.

#### Sections 15 Building and Development Standards 2015-04-15 DO Setback Clarification

This memo is intended to clarify that the above Setback requirement applies to Structures used for human occupancy on adjacent properties. The requirement is not intended to direct property owners in the placement of Buildings or Structures built to enclose animals on their own property.

#### Section 13 M-I Z2022-027 Town Pump Administrative Determination

THEREFORE IT IS NOW HEREBY ORDERED by the Gallatin County Commission that a bar that includes video gaming machines is a conditional use in the Manufacturing-Industrial Sub-District.

#### Section 13 M-I Z2014-014 Wildrye Determination

Based on the above analysis, the Planning Director hereby classifies distilleries and breweries as permitted principle uses within the M-1 District. A party aggrieved by this classification of use may file and appeal consistent with the requirement of 76-2-226 Mont. Code Ann. and Section 56 of the Gallatin County/Bozeman Area Zoning Regulation.

# Section 33 Definitions Z2018-015 Northwestern Energy Use Classification

THEREFORE IT IS NOW HEREBY ORDERED by the Gallatin County Commission that the definition of Essential Services (Type 1) in the Gallatin County/Bozeman Area Zoning Regulation shall be interpreted to include natural gas distribution lines and necessary appurtenances.
