DIRECTOR'S MESSAGE

I am pleased to share with you the 2022 Annual Report highlighting the activities and accomplishments of Gallatin County 911, operations, systems, and records divisions serving the Gallatin County community.

During 2022 we remained focused on completing projects and adding to our staff. While we met several challenges with both, our staff continued to work diligently. We saw challenges with hiring dispatch staff due to housing amongst other more traditional challenges we see around the country. We did see several positions filled with exceptional individuals. The highlight when it comes to hiring is at the end of 2022, the Records Division is fully staffed for the first time in several years. With this brought several different challenges such as not having enough space to facilitate everyone. These are great problems to have.

Regarding projects, we spent a majority of the year working on long term projects that would have a big impact for years to come. The radio project continues to be one of our priorities. While we were unable to complete this project in 2022, huge strides were made, and we see light at the end of the tunnel. Facilities were also at the forefront of our discussions this past year. Both the Records Division and the Radio Shop locations were in limbo. Ultimately the decision was made to move Records to the Farm Bureau building and the Radio Shop will be moved to the Coordination Center. These moves will not be quick, but steps have already been taken in the right direction. Lastly, the statewide 911 network has been on our minds and a move to a new Next Generation 911 system is in the works. This has been a long time coming. The work that has gone into the preparation of this system has been emotionally charged and political in nature, it is finally coming together. I expect 2023 to lay the groundwork for this new system that will serve Gallatin County and all of Montana for years to come.

Reading through this report, my hope is that you see that our staff has worked diligently throughout the year to accomplish our goals. I could not be prouder of the commitment and excellence that our staff exudes. Like any organization, there are times where we fall short, but with this staff, we pick ourselves up, take ownership and move forward. I am proud to work with both our internal team and our public safety partners.





TRAINING

- Purchased Al SkillLab Call Simulator through Priority Dispatch so dispatchers could practice medical protocols to gain experience before taking a live call and give tenured dispatchers the opportunity to practice medical calls.
 We are currently working on setting up the simulator for our dispatchers to get started using.
- ◆ Training Manager Delaware Steingruber applied to certify our training manual with APCO through Project 33 (P33) Agency Training Program Certification.
- ♦ Dispatch Supervisors Amanda Pratt and Jessica Sullivan attended the NENA Conference in Louisville, KY.
- Dispatcher Natalie Russell attended the Navigator Conference in Nashville, TN.
- Dispatcher Jennifer LaCross was nominated and voted in as Trainer of the year for Montana APCO.
- Director Tim Martindale and Assistant Director of Operations Tara Murker graduated from their CPE Programs.
- ♦ New Training Timeline was proposed, discussed, revised and accepted. The change created proficiency periods after phases 1 & 2. This change creates opportunity for the trainee to practice what they have learned on their own before advancing onto the next phase and when they are signed off training, they will already have solo experience. This extended the training program by 1 ½ months, making our new training program just short of 7 months.
- ♦ We Implemented a Communications Training Officer (CTO) Promotion. Dispatchers and Supervisors will now go through an application process in order to be promoted to a CTO.
- ◆ Added Standard Evaluation Guidelines (SEGs) to our Daily Observation Reports (DOR). This is to help ensure consistency with evaluating each trainee day to day and helps our training program meet the national training standard for that area.
- Dispatch Supervisors Amanda Pratt and Jessica Sullivan and Dispatchers Lana Fellows and Olivia O'Halloran attended Responder Risk training in Great Falls.
- Dispatchers Lana Fellows and Olivia O'Halloran participated in the MSU Northern Thunder Tabletop Training.
- Director Tim Martindale, CAD Administrator John Hinkle and Dispatch Supervisor Susan Walker attended the APCO Conference in Anaheim, CA.
- Dispatch Supervisor Jessica Sullivan attended NENA Supervisor Training in Utah.
- Dispatcher Sierra Stephens completed a 911 Training Institute Stress Course.
- ♦ Dispatchers Hannah Drake, Lana Fellows, Olivia O'Halloran and Natalie Russell participated in an Active Killer training at Sacajawea Middle School.
- Dispatcher Drew Greer helped Central Valley Fire Department with some Lieutenant training.
- ♦ Dispatcher Maya Crawford attended an Exxon Mobile tabletop exercise.
- ◆ Training Manager Delaware Steingruber completed the year-long Registered Public Safety Leader (RPL) course.












TRAINING (Cont)

- Dispatch Supervisors Jessica Sullivan and Susan Walker became certified in Emergency Medical Dispatch-Quality Assurance and Emergency Fire Dispatch-Quality Assurance.
- Dispatchers Josh Quimby, Maya Crawford, Morgan Perry, Hannah Drake, Sierra Stephens and Nicole Buescher became certified in both Emergency Medical Dispatch and Emergency Fire Dispatch.
- ◆ Dispatch Supervisor Amanda Pratt and Dispatcher Natalie Russell became Communications Training Officers (CTOs) to help train new dispatchers.
- Revision of the training manual to include P33 standards. Seven trainees began the training program, four of the trainees completed the program successfully. One trainee went through remedial training and did not complete the training. One resigned and moved out of state before completing the program. One is currently in training and doing well so far.

- ◆ A 35-test booklet was created that is to be completed by the trainee during their time in training.

- ♦ Dispatchers completed multiple fire and medical trainings through Priority Dispatch. Examples: Wildland Fire, Chest Pain/Chest Discomfort, Convulsions/Seizures, Headache, Outside Fire, Alarms, Stroke, etc.
- ♦ All dispatchers completed Active Assailant training through Priority Dispatch.
- Dispatchers Meg Tomczyk, Hannah Drake, Joshua Quimby, Sierra Stephens and Maya Crawford graduated from MLEA.
- ♦ Dispatch Supervisor Jessica Sullivan completed Academy Analytics and AQUA training.

ACCOMPLISHMENTS

RECORDS ONLINE REQUEST PORTAL

After nearly 2 years and with collaboration between Records Manager Bridgette Nyquist and Information Technologist Chris Erickson, an online records request portal was established for the Gallatin County 911 Records department. This portal allows the public to make paperless records request for the Gallatin County Sheriff's Office and Bozeman Police Department. It also provides the public the ability to pay online because Chris was able to create a payment portal within the website. The 911 Records Department is extremely excited about moving forward with this technological advancement to help move to a paperless process. Chris also created some posters that are posted on the window at the Records Department with a QR code that directs the public to the form to fill out. There will be one more step of getting kiosks set up at other locations like the new Public Safety Center for the public to use if they do not have a cell phone.

CONNECTIONS AND THE MOBILE RESPONSE TEAM

On July 16th the 988 suicide hotline went live. In line with that, Gallatin County also worked towards implementation of a mental health mobile response team. This team was discussed since 2021 and would replace the co-responder model that had previously been used. Throughout the year preparations were made for this new team. This included policy changes, agreements, selection of a vendor and hiring mobile responders. This all came to fruition at the end of the year. Gallatin County Mobile Response now offers services seven days a week and have become a great asset to everyone in public safety.

APCO'S AGENCY TRAINING PROGRAM CERTIFICATION (P33)

Initial and continuing training is exceedingly important for public safety telecommunicators because we provide essential services in an ever-expanding and rapidly changing public safety environment. Building and implementing a successful agency training program requires many resources and dedication. APCO's Agency Training Program Certification, an initiative of Project 33°, provides a way for public safety agencies to certify that their training programs meet APCO American National Standards (ANS). An agency's curriculum, training materials and supporting documentation are reviewed and checked for compliance. Submitting our program for APCO certification shows that our agency is committed to training and to meeting national standards. Our training program was submitted for certification on October 4, 2022. Nationwide, there are 92 agencies certified in Project 33°. There is only one agency in the State of Montana that is currently certified. This project requires a substantial amount of policy updating, collaboration and documentation to reach the standards required for certification. We are hopeful to receive certification in August 2023. Receiving certification for our training program will be a major accomplishment for our agency, staff and the communities we serve.

ACCOMPLISHMENTS (CONT)

RADIO PROJECT UPDATE

- All remote sites have been installed and are active.
- Radios are being programmed for use on the new system. By the end of December, we had 3 agencies completely programmed, one agency 50% programmed and code plugs in the works for 8 other agencies.
- Director Tim Martindale and the PSS team (Geoff Solberg, John Hinkle, Chris Erickson, Toby Morse and Emely Lambert) attended Factory Acceptance Testing in Texas with EF Johnson.
- Stargates were installed at all dispatch stations.
- Admin staff had console training with EF Johnson.
- Dispatchers had initial Stargate training in October. More dispatch familiarization with the Stargates occurred in December.
- Purchased 20 cache radios.
- Hired Eric Gillitzer as a radio tech to help Toby Morse.

OTHER ACCOMPLISHMENTS

- CAD Administrator John Hinkle was voted in as the Vice-President of the Montana Chapter of the National Emergency Number Association (NENA).
- Training Manager Delaware Steingruber was voted in as Montana APCO Western Ambassador and is also the APCO Awards Chair.
